Find attached a picture of a stained glass window I created in honor of my father, Rodney Nelson. I thought you might want to share it with the newsletter readers. My dad was a member of the 388th and spent a year in a German POW camp. I was always fascinated, as a child, by the stories he told. He loved to visit organizations like schools and churches and tell his story. I have heard it many times and I have a recorded version on my computer so I can listen to it but it was never the same.

As a kid I had so many questions and there was a fascination or mystery with his experience in

the military. I remember his stories of the military training, POW camp and of course the B-17. There are so many stories I could fill pages but I thought I might share a few.

At Christmas time, one of our neighbors about a quarter mile away put up lights along the eve of their house that twinkled or blinked and I remember him remarking how the blinking lights reminded him of the flash of the enemy fighters machine guns as they attacked the bombers.

His plane was not hit by flak or enemy fighters but it encountered mechanical failure so the crew had to bail out. He wore a little caterpillar

Good Afternoon,

I know this is a long shot but its worth a try. My great uncle Martin Targonsky was shot down and killed while serving with the 388th on November 9, 1944. My grandfather never talked about it because it ruined him so much. I served with the United States Marine Corps and over the last few years I've tried to get any info I could. Today I came across everyone who was on the plane and was only able to track down one person who passed away in 2013. Unfortunately I know most men and women from that time have past on but I was wondering if you knew anyone from that flight still alive that I could contact. 7 people survived that flight. I have the numbers B-17G-60-VE Fortress and also 44-8302. I don't know if that helps or if you

can help in any way whatsoever. Hopefully you can. Thank you very much.

I graciously replied sharing some options for further research along with suggesting he share the crew members' names he had collected.

Eric replied with the following message ...

Hi Cindy,

Thank you so much. Already just looking at the website I found stuff I didn't know! Ok so heres the name's of everyone on the flight that day. I hope you can just tell me if they are alive and can forward a message for me if they are. History is important to me and I want to pass it on to my children. The names are.....

I then sent that list of names off to our secretary, Ruth Castleberry who was able to locate a survivor and one widow through our membership database. Ruth is now coordinating the exchange of letters between Eric and the surviving members.

I can't tell you how happy I was! The connection has been made.

I asked Eric to jot down some notes about what this all means for him. Here's what he sent over.

I started looking in 2012 for any survivors from my great uncles plane crash. I reached out to a few places and was told there were no survivors still alive. That wasn't good enough for me. I knew there had to be someone who knew my great uncle or was even on the plane with him. So one night this year I decided to look again. I

hanging on the wall in my house so I am always reminded that there are stories I'm not too sure of. I got to searching again and came across your website and I think you know how thats gone for me. Ive reached out to Fred Abigt's family on Facebook and found that he was alive when I first started my search. So to me this means more than just the war. For starters, I love history. My great uncle is a Purple Heart recipient as am I so the need to figure out what really happened was really on my mind. Another and probably the last reason is that my family needs to know this. When my great uncle Marty was killed in action, my grandfather's life was changed forever. I remember always seeing the picture of Marty on the wall and thats it. No medals, no stories and too nervous to ask. Unfortunately, I never had the courage to ask about Marty or any other family history and my grandfather would die a year before I attended Marine Corps bootcamp. Now, at 27 years old, I want to know more. I want to make sure my future kids and grandkids know the stories. I want them to know how I fought in the desert and about the injuries I sustained for my country and our freedom. I want them to know about the "greatest generation" and how their family member helped serve and give everything he had in the pursuit of freedom. reg Staples remembers hearing a big "thump" as he was sitting down to dinner on a late summer evening in 1958 with his mother, brother and grandmother, who was celebrating her birthday. They looked out a window from their home on Fairchild Air Force Base and saw a B-52 on fire and ejection seats.

He and his brother didn't pay much attention to the schedule their father kept as a B-52 navigator, but their mother did. "She was on the front porch, screaming his name," Staples recalled recently.

Maj. Donald Staples, a World War II veteran who had flown 25 missions over Europe, was aboard Outcome 54, which was coming in for a landing at Fairchild. Another B-52, designated Outcome 55, had just finished a "touch-and-go" landing and was coming around for its final landing. Both were on training missions.

Outcome 54 was scheduled to practice an instrument approach; Outcome 55 was practicing visual flight landing. About 2 miles from the runway, over the town of Airway Heights, the two mammoth bombers collided, then exploded, sending a torrent of airplane pieces raining down. The two planes had 16 crew members between them; 13 died.

A memorial for Outcome 54 and Outcome 55

Capt Donald Staples was a proud member of the 388th Bomb Group and served as navigator on the Jarrendt crew, Gremlin Gus II, of the 560th SQ. He stayed on active duty after WW II and served in the Korean Conflict and the Cold War. His family is planning a memorial to commemorate the awful crash of two B-52 bombers that took his life in 1958. It was a beautiful late summer day. Outcome 55, a nearly new B-52D assigned to the 327th Bomb Squadron was completing a Cold War training mission and had called the Fairchild tower "just completed touch and go, going around for a full stop. End of mission." It's sister aircraft, Outcome 54, from the

325th Bomb Squadron of the 92nd Bomb Wing was making a simulated instrument approach. They never saw each other and collided over the small town of Airway Heights, two miles from the end of the runway. The 327th Commander was killed along with 12 other officers and airmen. Three men survived. The families are planning a granite memorial to be placed in Memorial Park, Fairchild AFB, WA. Peace is Our Profession

Dedicated to the heroes of the Cold War

On September 8, 1958 thirteen men lost their lives defending freedom during the Cold War with the Soviet Union when two B-52s collided in the Fairchild AFB traffic pattern 2 miles

Survivor 2Lt. Walter Maguire worm pin on the lapel of his suit coat. It was a silkworm and was given to anyone that used a parachute to save their life. It was quite a conversation generator and he was proud to tell you about it.

He was in Stalag 17. He always bragged that there was a movie made about his experience although he said the movie was nothing like the real event.

Time has made some of these events fade but there are certain ones that are still very clear. I remember him explaining how they didn't have much to eat but he added, "Neither did the Germans". As the end of the war neared the guards disappeared and the Americans left the camp in search of food. One particular story involved a bakery where the men went in search of bread. They entered and were told that there was no bread, it hadn't been baked yet, so they left. Most of the men moved along but dad suspected they weren't getting the truth so he stood in the shadows and watched seeing customers going in and out of the bakery, carrying with them loaves of bread. He went back into the bakery and found the bread and loaded the arms of his coat with four loaves and headed back to camp. A farmer passed him in a cart so he jumped on to catch a ride back to camp. He discovered a bucket of eggs the farmer was hauling so he took those and the bread so the men had fresh cooked eggs and bread. He claimed it was one of the best meals they'd had in a long time.

I grew up with an adoration of the B-17 that he instilled in me. I remember watching the television series 12 O'clock high with dad and I now realize that was a privilege. He was a side gunner and I envisioned many times, him standing at the window firing his 50 cal. Machine gun at enemy fighters as they streaked by. A B-17 came to the Twin Cities once for an air show so I asked dad to go with me to see it. It wasn't a pristine aircraft, it was used for hauling freight and hadn't been restored, but it was the first time I had the opportunity to go into one.

I wanted dad to join me but he declined, claiming he spent enough time in them and the last time he was in one he had to jump out. I took a picture of him standing outside the aircraft from the side gunners window which I thought was quite fitting.

Dad passed away in 1990 but shortly afterwards a completely restored B-17 came to the St Cloud, Minnesota airport so I took my granddaughter to see it. I wanted her to understand this part of our countries history and what her great grandfather flew in. It was remarkable. Completely restored and outfitted with guns, bombs and everything. We gladly paid a fee to tour the craft and we both went through it. We entered through the pilot's access door and viewed his controls and instruments, then the bombardiers location which was very fascinating and I looked into the top ball turret gunners location to understand his view. A highlight was to cross the catwalk over the open bomb bay doors and stand at the side gunner's location and touch the 50 cal. Machine gun and consider the events that my father experienced.

If you could afford the price, you could take a flight in that B-17 and we watched it "load up" several times. It was amazing to see those propellers turn over and hear those engines come to life. There is nothing quite like seeing that beautiful airplane lift off the runway and into the sky, just like they did so many times back in England years ago. A flight in the B-17 is definitely on the bucket list but it was just a bit too expensive that day. Someday, before I die, I hope to get the opportunity to fly in one and experience the sounds and smells and feelings it generates.

One last story, I was attending a softball tournament in the twin cities and I was coming up to bat and I heard this unusual aircraft so I stopped and stepped away from the plate. I looked up into the clear blue afternoon sky and there it was. A beautiful B-17, reflecting the sunlight and all four engines roaring as it flew overheard and the world stopped for a moment and

I was transported back in time and I envisioned that last bomber and crew making it home to its base and all was well with the world.

I enjoy the newsletter so much and I see the stories of these hero's disappearing in every issue with the "Taps" list. We owe so much to these brave airmen but they were just "doing their job". God bless their memory.



After many years out of print, *The Silver Lady* is available once again. First written in 1972 by 388th veteran James Facos, the novel has been re-released by Merriam Press.

A fictional account of the Starrett crew and their beloved B-17 during 1944, *The Silver Lady* was drawn from Facos's personal experience as ball turret gunner with the Arthur Moreland crew in the 560th Sqd. The crew flew 30 missions between March and June 1944 in their own *Silver Ladv*.

In addition to its vivid combat action (including a terrifying crash landing), the novel evokes deep personal memories of life at Knettishall.

The book also examines how the human spirit is tested when faced with the horrors of war.

A playwright, poet and novelist with several published works, James Facos taught English for 30 years at Norwich University and Vermont College. He and his wife Cleo live in Montpelier, VT.

8. Old Business

• Motion to Increase Annual and Lifetime Dues. Scott Long. James Zographos, proposed a motion to increase dues at the 2015 Annual Meeting. Consensus was to postpone consideration until the 2016 Annual Meeting.

The Board proposed to increase annual dues for all classes of membership except for life and honorary from \$10.00 to \$20.00 and lifetime dues from \$50.00 to \$75.00.

The bylaws currently state in "Article VI: Dues and Assessments, Section 1: Dues.

- A. Annual dues are \$10.00 per year for all classes of membership except life and honorary memberships. Annual dues may be fixed at any annual meeting by a majority vote of the members present.
- B. The dues for lifetime membership have been established as a one-time payment of \$50.00.
- C. Widows of life members will continue as life associate members without the payment of additional dues.
- D. Widows of non-life members can con-

tinue in associate membership upon pay-



ment of the usual annual dues (\$10.00) or can convert to life membership by paying the life membership sum (\$50.00)."

The proposed language would only change these two numbers, and if ratified, the Bylaws, Article VI would state in: "Article VI: Dues and Assessments

Section 1: Dues

- A. Annual dues are \$20.00 per year for all classes of membership except life and honorary memberships. Annual dues may be fixed at any annual meeting by a majority vote of the members present.
- B. The dues for lifetime membership have been established as a one-time payment of \$75.00.
- C. Widows of life members will continue as life associate members without the payment of additional dues.
- D. Widows of non-life members can continue in associate membership upon payment of the usual annual dues (\$20.00) or can convert to life membership by paying the life membership sum (\$75.00)." This motion proposes to amend "Article VI: Dues and Assessments, Section 1: Due; by striking out \$10.00 and inserting \$20.00 for all classes of membership except for life and honorary to increase annual dues, and by striking out \$50.00 and inserting \$75.00 to increase lifetime dues.

A motion was made from the floor to ratify the proposed amendment to the bylaws and the motion was seconded. Vote was taken by show of hands from the floor, the motion passed unanimously, and the amendment to the bylaws was adopted.

- 9. New Business
- Motion to Change Newsletter Delivery Procedures. Scott Long stated the background regarding a proposed motion to change the newsletter delivery procedures. The 388th currently spend over \$1,000 per edition mailing the newsletter to 950 recipients. The Board wants to make sure original members and their spouses who want a hard copy continue to receive one free of charge, but in an effort to make sure the Association is being a good steward of limited resources, the Board proposes the following motion to change the Newsletter delivery procedures. **Specifics:**
- Newsletter editor will e-mail the newsletter to all members with an e-mail address.
- Newsletter editor will send hard copies of the newsletter free of charge to original members and their widows who desire a copy, unless they prefer e-mail copies.
- Outside of original members and their widows, the newsletter editor will charge an appropriate fee to any member who wishes to have a hard copy mailed to them.
- Members will have until the completion of the 2016 Annual Meeting to convey their preference.
- Beginning with the fall 2016 edition, the newsletter editor will only mail hard copies to those original members and widows who requested a hard copy by the deadline.
- Pricing Options: Fall and Winter: \$4.00; Spring and Summer: \$4.00Fall, Winter, Spring, and Summer: \$8.00.
- Checks payable to Treasurer or via 388th BGA website.
- A motion was made from the floor to change the newsletter delivery procedures to email all newsletters as stated above to email newsletters to all members with an email address; send free of charge hard copies to all original members and their widows, unless they prefer an email copy; outside of original members and their widows, the newsletter editor will charge an appropriate fee to any member who wishes to have a hard copy mailed to them. Vote was taken by show of hands from the floor, the motion passed unanimously.
- 2018 Annual Reunion location. Scott Long. BOD recommended Boston, Mass. or Coco Beach, Fla. A vote by a show of hands from the floor was taken and the majority selected Boston, Mass.
- 10. Nominations and Election of New

Officers. Scott Long read the names of the

individuals nominated for the following positions:

- 2d Vice President. Tony Smith
- Secretary. Ruth Castleberry
- Corporate Agent. Henry Curvat

Motion made to ratify the slate of officers. Motion ratified and passed unanimously.

- 11. Other Business. Scott Long. August Bolino addressed the membership about the future Centennial of World War II, offering to establish a \$5,000 fund donated over three years supporting celebration of this event. Motion made to accept the funds with specifics to be worked out. The motion passed unanimously.
- 12. Motion to Adjourn. Motion to adjourn the meeting was made and carried by unanimous vote. Scott Long declared the meeting adjourned at 11:59 a.m.
