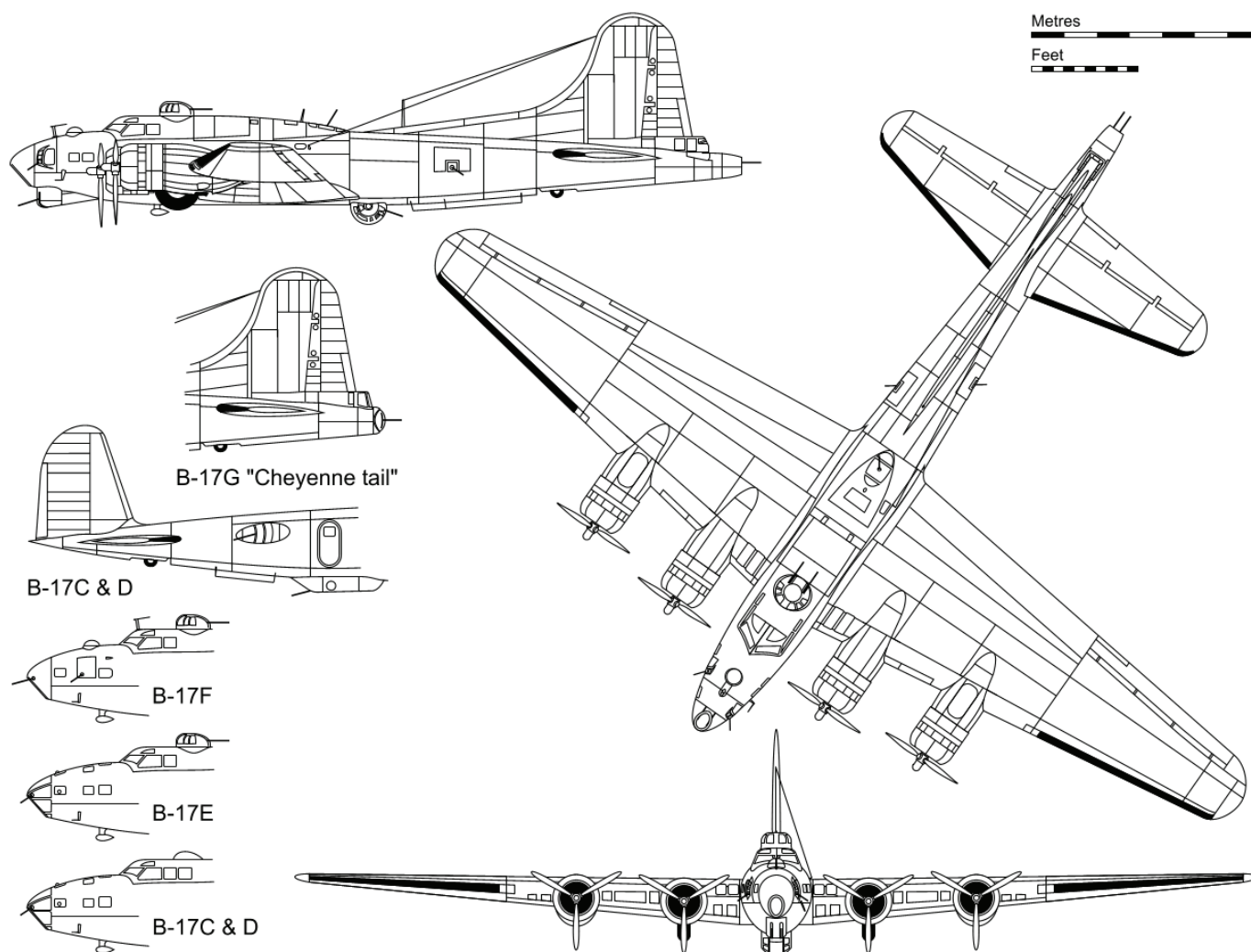

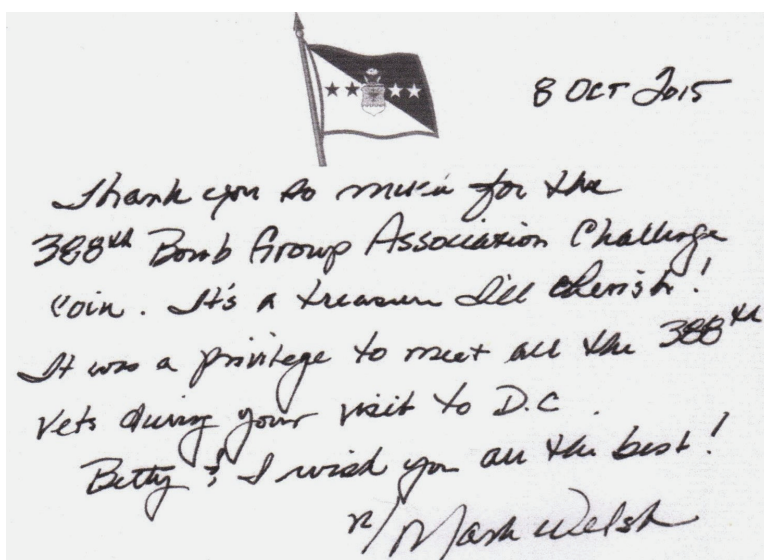

388th Bomb Group Motions To Amend Bylaws

1. The first motion is to amend Article VI of our Bylaws, Dues and Assessments. The Board proposes to increase annual dues to \$30 and lifetime dues to \$75. The proposed language would only change these two numbers, and if ratified at the Annual Meeting, the Bylaws, Article VI would state:

Article VI: Dues and Assessments

Section 1: Dues

- A. Annual dues are \$30.00 per year for all classes of membership except life and honorary memberships. Annual dues may be fixed at any annual meeting by a majority vote of the members present.
- B. The dues for lifetime membership have been established as a one-time payment of \$75.00.
- C. Widows of life members will continue as life associate members without the payment of additional dues.
- D. Widows of non-life members can continue in associate membership upon payment of the usual annual dues (\$30.00) or can convert to life membership by paying the life membership sum (\$75.00).

2. The second motion is to change the Newsletter Delivery Procedures. We currently spend over \$1,000 per edition mailing the Newsletter to 950 recipients, of which only 592 are original members and widows. The Board wants to make sure original members and their spouses who want a hard copy continue to receive one free of charge, but in an effort to make sure the Association is being a good steward of limited resources, the Board proposes the following Newsletter Delivery procedures:

- The Newsletter editor will e-mail the Newsletter to all members with an e-mail address.
- The Newsletter editor will send hard copies of the Newsletter free of charge to original members and their widows who desire a copy, unless they prefer e-mail copies.
- Outside of original members and their widows, the Newsletter editor will charge an appropriate fee to any member who wishes to have a hard copy mailed to them.

We are devoting a full page in the spring and summer 2016 Newsletter editions to request that everyone communicate via mail, e-mail, fax, or phone their preference for receiving the Newsletter, either by mail or e-mail. The notification deadline will be at the completion of the 2016 Annual Meeting, and beginning with the Fall 2016 edition, the Newsletter Editor will only mail hard copies to those who requested one by the deadline.

HOTEL INFORMATION

The Best Western Premier Waterfront Hotel & Convention Center on Main Street overlooks the Fox River and is located downtown Oshkosh. There is a boardwalk along the Fox River along with outside dining at the hotel. Just across the street is the Convention Center which is connected to the hotel by way of a skywalk over Main Street. Next to the Convention Center is the Leach Amphitheater which hosts a variety of entertainment on Tuesday and Thursday evenings.

The 388th Bomb Group Assn. rate is \$104.99 + 15% occupancy & sales tax + \$3.00 per night municipal services fee. Each room will receive a ten dollar (\$10.00) voucher (based upon occupancy of the room, 1 person = 1 voucher, 2 people = two vouchers) which can be used in the hotel's restaurant for breakfast each day of our reunion. Call 1-920-230-1900 or 1-855-230-1900 for reservations. Be sure to ask for the 388th Bomb Group Reunion rate. This special rate is available for 3 days before and 3 days after the reunion, if rooms are available.

Reservations must be accompanied by a first night deposit or guaranteed with a major credit card.

Cut-off date for reservations is July 15, 2016. Reservations requested after this date will be accepted based upon availability.

Parking is available at the hotel's parking garage which is attached to the hotel and is provided free of charge. Access from the 2nd floor of the parking ramp into the hotel consists of 5 or 6 steps to be climbed. Therefore, it is important to first unload & check into the hotel at the 1st floor lobby area before parking your car.

Thursday, August 4th will be spent at the EAA museum and grounds. Our day will start with a short introductory film about the EAA and then we will have a guided tour of the museum which houses an assortment of aircrafts. After we enjoy our luncheon at the museum we will be transported to the hanger where the B-17 nicknamed the Aluminum Overcast is housed. Everyone will be able to watch as this B-17 takes off and lands. Some of you may even be aboard!

Friday, August 5th we will be enjoying a buffet luncheon aboard the Showboat II while cruising along the scenic Fox River. This evening you will have time to enjoy the various activities that Oshkosh has to offer, such as the river walk, amphitheater, and downtown shops/eateries.

Saturday, August 6th everyone is invited to attend the annual business meeting. The afternoon is free to explore the Oshkosh area before returning to the hotel for the evening banquet.
